## **Yangarra Closes Private Placement**

**May 25, 2010**

**Yangarra Resources Ltd.** (“Yangarra” or “the Company”) (TSX Venture: “YGR”) is pleased to announce that on Friday, May 21, 2010 it closed its previously announced private-placement of 4,200,000 flow-through common shares of the Company at a price of \$0.55 per flow through common share for aggregate gross proceeds of \$2,310,000. Each flow-through share is issued on a “flow-through” basis under the Income Tax Act (Canada) and subject to a hold period expiring September 22, 2010. Finder’s fees of \$184,800 were paid in conjunction with the financing.

The proceeds from the sale of the flow-through common shares will be used the Company to fund qualifying expenditures in relation to the exploration, development, and production of the Company’s Willesden Green Area property.
